- Motion to approve payment to Rees-Broome for services in amount of \$552.50 was approved.

ARC (Donna Clay)

- Old business
 - o ARC reviewed additional information submitted by homeowner but did not approve
 - Letter will go to homeowner advising that request for reevaluation was denied and will advise of right to appeal to the Board
 - ARC inspected approximately 24 houses in walk-around; remainder should be done by the end of May
 - o Pictures of homes will be taken and saved onto disk. Photos of homes with violations will be sent to homeowners
 - o No Board member will inspect his own home or that of immediate neighbors

- o Suggest including in next newsletter a list of most common violations
- New business
 - o The second public ARC meeting was held tonight
 - o Voted on 5 requests, all of them approved unanimously
 - According to Rees-Broome, there will be a vote in June in the General Assembly on the right to fine
 - ARC voted to raise the authorized fence height from 6 feet to 7 feet needs Board approval
 - Motion that Board adopt ARC recommendation to raise the authorized fence height to
 7 feet from the current 6 feet was passed.
