# Treasurer's Report

- Linda Eyler (for Jack) submitted the Treasurer's Report (separate document) and noted two corrections: (1) account receivable: delete \$152, (2) Countrywide CD date: June 1, 2009 maturity date is correct.
- Two homeowners have outstanding 2008 due payments. One is overseas but Jack is trying to contact them. One is local.
- Motion to accept report. Moved and accepted.

### Land Use

- We received a letter from Fairfax County in April re Emerald Ash Borer. County will do survey and lay traps if needed (large purple hanging boxes). Survey tiem is April August. Board agreed to note in newsletter to notify residents.
- Recent meeting –VDOT wants to reduce the speed limit on Rt. 1 citing pedestrian safety. VDOT is supposed to collect feedback from neighborhood associations. Board members noted pedestrians frequently cross at various areas although crosswalks and signals are provided.
- Wegmans is due to open June 2011 in Kingstowne area.

She was reminded that no alterations can be made to the area without permission from the neighborhood at large. The board does not support any unilateral action by any homeowner.
- O It was stated that is the board's intent to ensure that all credible information on legal, environmental and other considerations regarding the common area be collected and reviewed by the common grounds committee to be headed by Bill Jewel. This committee will report items to the board for its consideration. Items that would result in increased fees/dues or alter common areas must be presented to homeowners at large for a vote prior to taking action. This excludes immediate needs of tree removal for safety and liability.
