REPORTS:

Secretary's Report (Debbie Halla for Alyssa Crowder who was absent) -

Deb Halla made a motion to accept the September 14 as written. Motion passed unanimously.

President's Report (Debbie Halla) -

Discussed Florence Lane sidewalk and Verizon FiOS installation. Motion to approve report passed unanimously.

Treasurer's Report – Linda Crawford for Jack Eyler

No income for this month. Block party expenses. Net income \$5,700 for the year. Assets \$19K, liabilities = 2 outstanding homeowners, Mt. Comfort cemetery to reimburse engineering costs.

ACC Report – Arienne Reilly

Motion to approve ACC Report. Motion passed unanimously.

Deb to revise 2 documents presented (notice of annual meeting and proxy) and mail by 1st class postage this Fri. Motion passed unanimously.

OTHER BUSINESS

Lighting Issue at 3307 Wooden Valley Ct. - Debbie Halla

ACC previously voted down request from a homeowner to notify the homeowner of 3307 Wooden Valley Ct. that a lighting fixture in their backyard violated the ACC Guidelines.

Current ACC Guidelines state, "(a) No exterior lighting shall be directed outside the homeowner's property. (b) proposed lighting fixtures must be compatible in style and scale with the applicant's house. (c) No prior approval is necessary."

The homeowner lodging the complaint stated that the fixture at 3307 was "omni-directional" – however the guidelines state the fixture cannot be "directed" outside the homeowner's property. Thus this "omni-directional" light does not meet the above definition of "directed lighting" and therefore is not a violation of that ACC Guideline.

Motion made by Debbie Halla to uphold the ACC ruling that the lighting fixture at issue is not a violation of the ACC Guidelines. Debbie Halla to notify the homeowner who expressed concern.

Revisions to ACC Guidelines

Need to add VA State language on fees for violations. Arienne read through the revisions. Motion to approve report – motion approved unanimously.

Given the late hour for the meeting, the other agenda items were tabled for discussion at a later meeting.

Motion to adjourn meeting passed unanimously.
