- Payment of 2016 annual assessments was due on 2/29/16; to date, 80 members have paid. Payments not received by 3/30/16 will accrue interest from 3/1/16 at a rate of 8% per annum. A reminder to pay the assessment will be sent to homeowners.
- Legal expenses are high due to the ongoing court case. There was a question whether the HOA liability insurance should cover these legal fees. Kerry McCabe will contact the HOA insurance agent for clarification.

- Insurance
 - A summary of current policies and coverage was provided.
 - The need for an additional policy which covers volunteers at HOA activities was discussed; it was
 determined that the policy is not needed. The policy covers volunteers performing physical labor
 for the HOA; our volunteers are not involved in physical labor.
 - If needed, event coverage is available at low cost for the block party and similar events. [Note: Current policies do not cover the "moon bounce" at the block party. If we have a moon bounce, our agent recommends that the moon bounce provider be covered for \$1M/\$2M with HOA as additional insured.]

- Community Resiliency Working Group (CRWG) members are not covered under current HOA policies. In order to avoid any HOA liability issues, there should be no formal affiliation between the HOA and the CRWG.
- Volunteers are needed to assist with HOA IT support.
