Steve Piper established that a quorum was present.

Steve Piper welcomed all present and stated that the only item on the agenda was a discussion of the HOA's outstanding legal fees. He provided a brief background on how these costs were incurred and the fact that approximately \$67,000 of the outstanding fees result from litigation involving the Manning case and resulting HOA corporate status issues.

Tim Rogers provided a detailed timeline and discussion of all pertinent events affecting the legal fees. At the conclusion of his presentation, all Board members provided comments and recommendations. Board members expressed concerns that the 2008 internal misfiling of the 2008 Articles by our legal counsel, Rees Broome LLC, may have contributed to the dispute on the HOAs' corporate status and ensuing legal fees. Board members also expressed concerns that R-B's failure to provide bills and account status in a timely manner impacted the Board's decision-making.

<u>Motion</u>: Authorize the HOA president, with another Board member, to engage in discussion with Rees Broome concerning a significant reduction in the outstanding legal fees associated with the litigation.

- Michael Tanner emphasized the need for the Board to develop a plan or strategy that goes beyond negotiating fees with Rees Broome but also considers other potential legal issues.
